

BRILEY TOWNSHIP SKATEBOARDING ORDINANCE

01-05-27-91

An Ordinance of the Township of Briley, Michigan, providing for the regulation and control of the use of skateboards in private parking lots, publicly-owned parking lots, publicly-owned parks and recreational areas, public streets, alleys and sidewalks.

Be it ordained by the Briley Township Board of the Township of Briley, State of Michigan, as follows:

Section 1. Definitions. As used in this Ordinance, the following terms shall have the following meanings unless the context clearly indicates a different meaning:

(A) Business Parking Lot: Any privately owned parking lot providing free parking during business hours adjacent to any store, office building, commercial building or industrial building, for the convenience of employees and customers or patrons.

Section 2. Skateboards Prohibited. No person shall use, stand on, ride or be upon a skateboard in any private business parking lot or parking area, publicly-owned parking lot, or publicly-owned park when the riding or standing on, using or being upon a skateboard is prohibited by the owner, occupier, manager, or party having control of same, as indicated by a sign posted at the private business parking lot or parking area, the publicly-owned parking lot, publicly-owned park.

Section 3. Signs. The prohibition recited in Section 2 of this Ordinance shall be effective at any private business parking lot or area and at any publicly-owned parking lot, publicly-owned park or recreational area where the owner, occupier, manager, or party having control of same, has posted a sign or signs clearly stating the prohibition. The signs referred to herein shall not be less than one (1) square foot in area and shall have letters not less than one and one quarter (1 1/4) inches in height which shall read "Use of Skateboards Prohibited by Township Ordinance". These signs shall be posted at each entrance to the property, or if such property has no definite entrance, or entrances, they shall be posted in at least two prominent places on the property where they are clearly visible from outside the property.

Section 4. No person shall ride, stand on, use or be upon a skateboard on any public street, sidewalk or alley in the Township at any time. This activity is prohibited without the necessity of posting any signs as required in Section 3 above.


Section 5. Penalty. Any person, firm or corporation violating any provision of this Ordinance shall be fined not more than \$50.00 or imprisoned for not more than thirty (30) days, or both so fined and imprisoned in the discretion of the Court, for each offense or violation committed hereunder.

Effective Date. The provisions of this Ordinance shall take effect thirty (30) days after being adopted by the Municipal Council and duly

published.
